To make sure your withdrawal request is processed speedily, please ensure that you read the below instructions carefully and properly understand them. If you have any questions concerning the withdrawal process or instructions please contact accounting@smartradefx.com

Please read these instructions carefully before filling out the withdrawal form.

1. Our withdrawal form allows you to TYPE in your information into the specified fields from your computer. In order to ensure that instructions are correct, we require all information to be typed into the fields and not hand written.
2. Please print the typed out withdrawal form and manually sign it with your signature. Then you may scan and email it back or fax it in.
3. Please type the full customer name (the name in which the account is under)
4. Please enter the email that you use for correspondence with SmartTradeFX
5. Please type in the customer ID (your account login number)
6. Make sure to indicate which withdrawal method you prefer – Credit card or Bank wire
7. As this is an international bank wire please make sure to provide the SWIFT CODE
8. You must specify the exact numeric (\$\$\$\$.\$) amount you would like transferred in the amount box.
9. Please provide your complete mailing address, as it is necessary for verification procedures.
10. Please include the full address of your Home Banking Branch.
11. If your bank uses an intermediary bank to receive international wires please include that information.
12. Any mistake filling out the withdrawal form will result in a delay of your request.
13. If your wire is returned due to incorrect information you will be held accountable for fees charged to you by the bank.
14. Withdrawal forms will be processed by accounting between, Monday – Friday, 9am-5pm EST. Withdrawals will be processed within 48 hours of receipt and may take up to 7 business days to be received once processed.
